#### Call to Order 7:00pm

#### **Commissioner Comments**

Commissioner Green has a meeting with Parks & Rec on July 21st to discuss collaborations with the City regarding the events calendar for the year. They're going to see if there's any way the Port can be involved in social events. There has been positive reception with the idea and there is some momentum collaborating with the Historical Society events in October. She has been approached by the Historical Downtown Poulsbo Association about collaborating for a boater package for the Poulsbo Film Festival also coming up in October. Both of those events are now on the calendar to draw in more crowds.

Commissioner Rose said, over the 4<sup>th</sup> of July, Liberty Bay was full of boats, and it was truly an impressive sight seeing a dozen boats in a perfect fan. The Valkyrie Viking ship is 98% complete. At this time, the ship is staying in Anacortes and welcoming visitors while continuing efforts to complete the ship and get insurance in line. They're also working on documentation and the homeport is still Poulsbo. They're looking at garnering the right type of crew; preferably people who have a heart for Nordic history and a passion for youth. They're aiming for the ship to be ready to go April 2024.

#### **Public Comments**

Craig Muller wondered about the annual budget. He inquired about the agreement with DNR and if the MOU is in writing or verbal. If the agreement is verbal, he has dealt with DNR and suggested a written MOU with them to cover the marina. He asked if the bay has ever been surveyed. The Port needs to be careful about being liable for outside DNR jurisdiction. Today's the first day it has come out that the lock failed on C Dock. It would be a good idea to keep everyone updated when it happens so boat owners can check their boats, and not 4-5 days later. Finally, Port shouldn't be providing money to fund things with the City when funding is already tight with the Port.

Jason Lawrence has been observing maintenance, which has been a big issue. The ladders are a simple fix to keep them out of the water and he has suggestions on how to easily address the issue. He feels the Port is lacking on safety, it has been neglected for some time, even with previous staff members. He wondered who the safety coordinator is and read aloud a safety regulation.

Loren has been talking to Eugene and wondered if all the key locks would be the same across all gates. As far as he knew, Eugene had no definitive answer to what the plan is. He also touched on all the bird excrement and it being difficult to avoid. He also mentioned going to the Police

Department and getting free mini cans of Narcan, which can save lives, and there's a three-minute video online that shows people how to use it.

Barb wondered about the kayak dock that was built and if it was available to rent.

Sean Curry said with the new gate situation that his boat is vulnerable on D Dock during open weekday hours. The public has been known to board boats and he wondered about signage stating boats are private property.

Patrick Brooke suggested thinking about upgrading the system into something with more updated technology for gate usage. The Port may get a better insurance rate with the improvements. He moved to the Port because of the reasonable priced moorage, and because where he was had a dock out toward the breakwater like what's now being developed. It's a full-time job being pressure washed and it never did smell good. The seals need to immediately be discouraged from sticking around.

Terry said the low tides out there other day look like a dangerous place to go through, especially for the rowing club.

#### Old Business Items Breakwater Report

Mr. Piccone said we're still waiting on finger piers. The full fire suppression system was tested in early June. There were a few minor items found and fixed. The test was successful and accepted. The fire department was notified that the system is fully operational. There's a little remaining electrical work that has since been finished, inspected, and passed inspection. The power is on, and lights are on in the evening on walkways. Temporary wood ramps have been installed for access until the aluminum ramps are shipped and installed. With the exception of any mess from construction workers, future cleaning will fall on Port staff. The aluminum ramps anticipated arrival is late July and will be installed once in hand. The navigation lights are still a

struggle to get shipped out and he's hoping to receive them late July, but possibly they'll be here in August. Still no luck securing a firm date for delivery with BMI for the finger piers. There's a reasonable expectation mid - end of August for delivery based on communication and approval timeframes. Once those items are done and in position, we can start closing out contracts, start reimbursement requests for grants, button up paperwork, and finalize the Army Corps permit.

Regarding E & F Dock transient moorage, we are working at a quick pace to prepare the full design for bidding the work as previous discussed at the workshop meeting. The fuel barge will be moved out 32 feet, along with the multipurpose building. The dock will remain in place. We are at 30% design and the budget for the scope is the same as previously planned based on grant receiving. He will continue keeping Port Accountant Tripp updated on cost estimates as designs are moving along. He's working to have things ready to go to bid in September. As soon as the design is further along, he will reach out to key material suppliers for lead times on materials. Mr. Piccone is looking to do construction within the 2023/24 work window. Material procurement is a wild card. He's going to chase that down as design moves along so we can get materials needed within the fish window.

The Army Corps permit was put in long ago and it is sitting, not moving forward due to tribal objections for moving outer docks out further. The current plan is to apply for an emergency authorization to proceed given the urgency around the fuel dock. The floating restroom design is at 90% completion. There are two manufacturers for the job, according to what we want and the what the grant agency wants. He's working with the two vendors with design and cost. He will provide an update once available.

Port Accountant Tripp said there are FLUPSYs planned for the Port at some point in the future. The gate key fobs are pre-programmed and will keep track of who accessed what area and that data can be looked at if needed. The Port has a Port Management Agreement (PMA) with DNR, which does more than a Memorandum of Understanding (MOU). It is available on the Port's website for reading.

#### **New Business Items**

#### **Commissioner Responses to Public Comments/Discussions**

Commissioner Rose said future upcoming working sessions will be looking at several items. Such items include approving tariffs; the budget; discussing and reviewing rules and regs; reviewing policies that need updated and changed; reviewing and developing a more comprehensive plan; developing a ten-year framework built on future commissions; going back to other items of concern such as marketing, personnel, etc.

#### No Wake Buoy Joint Effort with PYC/Liberty Bay

Commissioner Rose said he wasn't aware of damage to the docks, to which Port Accountant Tripp said there isn't any damage (yet), but maybe we can integrate this in the future. Poulsbo Yacht Club and Liberty Bay Marina funded and installed two new wake buoys. There has been an increase of inexperienced boaters waking out the marinas. It's a concern to the rowing association and our marina. It's \$2600-\$3500 for a buoy (including permitting and installation), which we cannot do at this time.
