#### **RESOLUTION NO. 2021-15**

# A RESOLUTION OF THE PORT COMMISSION OF THE PORT OF POULSBO, WASHINGTON APPROVING CERTAIN EXPENDITURES FOR REIMBURSEMENT FROM THE PROCEEDS OF DEBT TO BE ISSUED IN THE FUTURE.

Section 1. The Port of Poulsbo, Washington (the "Port") reasonably expects to reimburse the expenditures described herein with the proceeds of debt to be incurred by the Port (the "Reimbursement Bonds").

Section 2. The expenditures with respect to which the Port reasonably expects to be reimbursed from the proceeds of Reimbursement Bonds are for breakwater and fire line improvements (the "Project").

It is anticipated that a portion of the costs of the Project initially will be paid from the Port's General Fund.

<u>Section 3</u>. The maximum principal amount of Reimbursement Bonds expected to be issued for the Project described in Section 2 is \$5,500,000 plus allocable costs of issuance.

Section 4. The adoption of this resolution shall not obligate the Port to issue the Reimbursement Bonds. The issuance of the Reimbursement Bonds shall require separate and additional official approval by the Port Commission.
