Call to Order 7:00pm

Commissioner Comments

Commissioner Singer said, from Florida, it's 80 degrees, sunny, and wishes everyone was there. He said Pam mentioned water hitting and coming over the breakwater; that's why it's a breakwater and it's doing a good job. He's looking forward to being home.

Commissioner Green said the Poulsbo Historical Society is hosting an I Spy event with lemonade and cookies on Saturday the 22nd from 11am-4pm. A new business, Spice and Tea Exchange, is officially open.

Commissioner Rose is looking forward to Monday's All Port's meeting.

Public Comments

Nico read a statement for Rick and Mary. May 22nd, 2022, they came to end of F dock. They were informed of a reservation coming in next day and need to move boat to different slip for next night. The weather was blowing at 30 knots, and the reservation had cancelled due to weather. The following morning, they went to pay for second night of stay. Chris approached the boat an hour or two later to inform them the customer who had previously cancelled would still be coming. The wind was blowing at 30-35 knots and pinning them to dock. They could not relocate the boat without damage being done to the boat or to the port dock. They understood there was confusion with the other vessel and offered to pay for the extra 10' and offered to lend the incoming vessel 30-50amp splitter so they could plug in effectively. They also offered to move as soon as the winds allowed them to do so. They were seeking safe harbor as to not create accident or human safety issue. Chris then became hostile toward them and told them they "had to get off the fucking dock and leave no matter what." They told him no because it wasn't safe to leave. Chris came back with Eugene, who agreed it was too stormy to move the boat at that current time. Chris became angry and said it was "bullshit" and they "had to move because of the reservation." Again, they claimed safe harbor. Chris was waving his hands around and making a scene. The reservation arrived at 9pm. Rick and Mary helped secure their lines and offered to help hook them up to electricity. The boaters said it was no big deal, they were just happy to arrive after making the passage in such foul weather. Chris had a bad attitude around them for weeks and went out of his way to be unpleasant. It made their stay and subsequent visits very unpleasant. They were told by Melanie that Chris would be written up. December 29^{th,} they arrived by dinghy and saw a large round fender. They heard Chris say, "It's Aaron's; I just got back from cutting it." Nico was stopped for the three-minute mark.

There was another statement about Chris. The first week in January he observed a situation on the dock. The individual approached Chris and Eugene and asked why his boat had been tagged. Chris said it was because he didn't pay. The man said that he did pay, and Chris called him a liar.

Then he went to the office and Jannese confirmed he had paid, and the wrong boat had been tagged. He went back and told Eugene and Chris that he had in fact paid, informing them of the mistake. Chris became very angry, threatened violence, and challenged the man to fight. Eugene who observed all of this, stood there, and laughed. The individual upset by this and fortunately was wise enough to walk away. The person who observed the situation expressed to him his frustration at being threatened this way and treated this way. He wondered who he was supposed to make a complaint to when the manager was laughing at the situation. He was deeply disappointed in the way some people have been treated by some staff. Management should never allow threats of violence to be offered by one of their employees and the behavior has been damaging to the Port of Poulsbo reputation in the maritime community. The person who observed this situation was afraid of retribution and did not want to come and speak.

Aaron wanted to share the Port of Poulsbo conduct and behavior policy just in case Commissioners and management hadn't read or understood the rules. The conduct and behavior policy are specific to what these statements are about and beyond. He then read aloud rules 1-5.

Old Business

Breakwater Updates

Mr. Piccone said the connector walkway between AA and the breakwater is now in place. The crews are working to finish all connections between the main marina and the breakwater. The project power and light pedestals are 90% complete and most of the electrical feeders are in place. The fire extinguishers are fully installed. All electrical should be complete within the next

few weeks. Some items such as ladders, life rings, navigation lights, etc., have been subject to backorder issues throughout every industry. Everything will be installed once it arrives. In the meantime, the old navigation lights are in use. The schedule for the finger floats is unknown at this time. Though he has continued to have numerous discussions, BMI has yet to submit drawings that provide floats that are acceptable in terms of quality and performance in the plans and what the Port is paying. He will be in touch with Port Accountant Tripp with updates.

Most of the other heavy work will be completed within the next three weeks. The crane barge will likely demobilize, but it'll be back for installation of the finger floats once they arrive. The E & F dock survey work will take place in the next couple of weeks. He doesn't have a set date confirmed with the surveyor and will let Eugene know the information once he has it.

Mr. Piccone is working with L&I in the next couple weeks for electrical permitting. He is asking them to relieve the Port from bringing all things up to the current code, but to maintain the code in which they were installed. He did get that confirmation from DNR. The electrical work associated with E & F dock need only happen in proximity of the gangway.

The Corps permit for the project is being pushed. There are questions regarding the tribe and he's in the process of answering them. He knows that, unofficially, the Port is receiving the grant and the official announcement will be in June/July. He's working with RCO to finalize the grant agreement to start submitting reimbursement on drawings, planning, design, and ultimately, construction.

The remaining item on the permanent moorage side is access improvement and gates. The fabrication of the four new gates was awarded to Mantel Industries. He's working with them regularly to approve materials and submittals for ordering the new lock sets, and answering their questions as they order materials and prepare to fabricate the gates. He's also getting ready to order key fobs and lock programmers once the new lock system is in place. Mantel Industries will also work to modify the existing C dock gate. No significant changes are happening except modifying the old lock to the new lock system. The door will be off for a few days to a week while they get the new lock installed. He's expecting it to be the end of June before we see gates out there and installed.

Regarding the CBA grant for the floating restrooms, things were stalled because the Army Corps allowed us to proceed with the breakwater but not the floating restroom. It's still part of the final permitting of things to do and we are coming up on the grant deadline. He had a chat with the CBA and got their permission to extend the grant for the floating restroom. He sent the info on escalation to the construction industry and was awarded an additional \$40,000 for the floating restroom to cover escalation. That's enough added money to upgrade the pump out system on C dock.

Change of Meeting Format

Commissioner Rose said many other Ports, particularly the Port of Kingston, have a blend of working meetings so the commission can come together with staff, and then have one meeting with an actual business meeting. He recommends the Port of Poulsbo shift to a similar format and essentially get together in a public format with Commissioners, staff, and members, so the public can witness the planning and dialogue reviewing marketing issues, plans, strategic planning for infrastructure, the comp plan, and the eventual expansion of the Port district. The board could review the Port policies openly. The public type a meeting means no decision can be made, but decisions can be made in a business meeting. His suggestion is to shift to a general meeting the first Thursday of the month, and the third Thursday of the month would be the planning meeting.

Commissioner Singer recommends this format. He believes it'll allow better communication and discussion. The general community can listen in and give the board the ability to sit and talk more in depth, which is something the board can't do with the current format. There are long term plans the board needs to discuss and put together and say how it'll be done. A lot more needs to be done for the Port.

Commissioner Green is willing to try this out for six months and then reevaluate.

Motion: Move to adopt a change in meeting format to a general meeting on first Thursday of the month, and a collaborative meeting the third Thursday of the month to meet the board's current schedule for a six-month trial period.

Parking - HDPA/Port Interlocal Agreement

Eugene said they're in the very beginning stages of planning but wants to let the board know what's happening and where things are. He thinks the Port can utilize the parking lot otherwise without breaking any parking rules for the licensees. He will stay in touch with Port Accountant Tripp, and she's already worked out what the Port can do money/cost wise. He's hoping to work on an interlocal agreement to help downtown businesses create parking for employees.

New Business Items

Commissioner Responses to public comments/discussions

Commissioner Singer thanked everyone for bringing their views and keeping everyone informed. He loves being part of the Port, being a Commissioner and lessee. He's going to make things better down here and wants to keep things moving forward.

Commissioner Rose appreciates and is aware of the reiterations of the various incidents that have happened. They're working in close communication with the Port's legal counsel and

things will be followed through with. It's a frustrating part of the process, but the board is committed to seeing it through.

Request for future agenda items and public comments

Paul is still entertaining a solution to his issue that happened at the beginning of the year. He hasn't received a response to several emails sent. After a brief exchange of communication regarding who has sent emails and who has replied to them, Commissioner Singer said he will gather data and discuss with the Port attorney to finalize issues. He will be in contact with Paul, Nico, Aaron, and Eugene, put all emails together in chronological order, and bring all paperwork together to bring to the Commission. Commissioner Singer doesn't believe the board has been ignoring any issues; there is confusion, and he will be the designated individual to handle it.

Nico said the concern and complaint process feels esoteric. If people are submitting statements that can't be used legally or professionally then provide a solution. The Commission can create a form they want people to use that has everything needed so it can be used. You're talking to us like there's only one way for that to go and the problem is getting bigger. The Port needs to figure out how to put it to rest before things get so heated.

Aaron said liabilities are going to continue.

Port Accountant Tripp said Eugene will need to amend the bylaws to change the meeting format.

Paul said six slips were available and offered to people on waiting list. He was curious if anyone knows the size of slips and the waitlist.

Commissioner Comments

Commissioner Rose said it isn't easy, but we're all together. Sometimes it's rough but the board is working within the constraints of what the Commission must do. He thanked the City for things they've been doing, and was thankful for the encouraging emails that have come in.

Commissioner Singer thanked everyone attending. He will get with Nico, Aaron, Paul, and Eugene and put together something that meets their timeframe and get things straightened out in a manner that works for everyone.

Commissioner Green thanked everyone who attended and for their insights. She said the forum idea is brilliant and a good idea to implement. She encouraged everyone to stay warm.
