# Call to Order 7:00pm

#### **Commissioner Comments**

Commissioner Singer said he is glad to be here for the beautiful weather. He stopped by on a dinghy at Liberty Bay and had the chance to walk around. He said it's been an enjoyable weekend for everybody here.

Commissioner Green said it's the time of year to be mindful of the water friends and animals. She encouraged everyone to enjoy the water and nice weather.

Commissioner Rose wants to do what is possible to encourage people to remain aware of their wake. He also suggested renewing the No-Wake buoy and moving it further out. A two-foot wake coming into the marina is a citable offense.

#### **Public Comments**

Gary Retter wanted to thank Commissioner Rose for his service.

There was a comment about the impact of the wakes on the rowing community. The rowing association requested to be on the east side so they're not by big boats coming in. People don't look down as much as they should, even when out there signaling for people to slow down, people seem to think rowers are just waving.

#### **Consent Agenda**

#### **Old Business**

#### Breakwater Update - John Piccone

The breakwater itself is 98% complete. Contractors have mostly demobilized. There has been trouble with a few items on backorder and shipping hold ups. These items include life rings, navigation lights, and aluminum ramps. As soon as anything arrives, it'll be installed. The acceptance hydrostatic pressure testing for the fire suppression system is scheduled for June 8<sup>th</sup>. The final inspection for potable water and electrical is scheduled for the week of June 12<sup>th</sup>. All utilities are in good working order. Bellingham Marine's unwillingness to provide finger

floats on time in accordance with plans they provided has resulted in several months of delays. Earlier this week, Bellingham Marine agreed to construct floats based on requirements given in the plans and specs. They're preparing what he hopes will be the final submittal for final review. Quigg Brothers have been pressuring them on a delivery schedule. It'll take them at least another week or two to get that submittal finished and three to six weeks if they're working efficiently to construct finger floats. It'll be five to eight weeks before finger floats are in Poulsbo. The negotiations with the Suquamish tribe still need to be finalized, which can then finalize the Army Corps permit.

The preliminary items and surveys are complete for E&F Dock. The engineer design will be taking place over the next couple of months in an effort to bring bid docs at the 95% level. Mr. Piccone wants to put the project out for bid in the September-October timeframe, which will allow the work to be completed within the next fish window before the 2024 boating season. He's talking with Port Accountant Tripp about the remaining permitting items to resolve and the issues with the breakwater to get both moving along. Once the Port officially receives the grant award in June or July, they can begin requesting reimbursement on everything to date.

CMI is the mothership company of Mantel Industries in Bellingham. All four new security gates are fabricated for permanent moorage access. He is coordinating a delivery date. The floating restroom will be located along the new connector between AA and the breakwater. He is moving forward with the procurement items, and it's basically the same story as the 30' finger piers. As soon as the C-AA gates are installed, the existing C Dock gate will temporarily be removed for a quick aluminum welding fabrication so it can accept the new locking system.

#### **New Business Items**

# Commissioner Responses to public comments/discussions

Commissioner Singer suggested moving rowing piers because it won't be as wide as it is now once the finger piers are in. Port Accountant Tripp said the same location is the best place for the rowing association. They will have 116' on AA between the last float and where the breakwater float extends out to the 30' finger pier.

Commissioner Rose said it's important to work from a "glass half full" perspective. As the Port moves forward from the breakwater project, E&F Dock, and X Dock, that is just the tip of the iceberg. The Marina has to be rebuilt and we're all going to have to work together. The more that we can relate and carry on keeping each other informed, the better. He believes to be ahead of the game right now.

Commissioner Rose said while reviewing rules and regulations, if anyone wants a copy they can be provided one. He requested recommendations or error corrections. He also touched on boats at anchor and how they're not lit or don't have proper signals. He encouraged people to have LED garden lights for visibility and safety purposes.

# Accounting Report – June 1, 2023

The 2022 Annual Report was filed with the State Auditor's Office on May 8, 2023. Copies of the report were emailed to all Commissioners. The good news is that the Port received less than \$750k in Federal grant monies and will not have a single audit this year.

Representatives from Enduris will be here on June  $6^{th}$  to see the new breakwater. I have requested a quote for insuring the breakwater. This will be a board action item if you'd like to insure it or not.

The resolutions that were approved in the consent agenda items will require signatures before I transfer the funds. Please sign these documents as soon as possible so that I'm able to move the funds promptly. After the transfer of funds, the approximate total in the funds will be:

- Contingency Reserve \$488,718.82
- Liberty Park Investment \$52,020.82
- General Investment \$1,053,529.47

A worksheet was forwarded to the Board with the calculation of the '2022 Economic Impact of Boaters Visiting the Port of Poulsbo Marina.' The amount of funds generated, exclusively by boaters to the downtown area was over \$4 million dollars (\$4,080,020.88) in 2022.

A budget vs actual comparison was emailed directly to the Commission for the period of January 1, 2023, to April 30, 2023. Except for Guest Moorage and Fuel Sales, all income/expense accounts are within expected amounts. As of April 30, 2023, the year-to-date net loss is \$1,371,518.53. This was expected and is due to the replacement of our breakwater.

Parkmobile has worked out very well for the Port. Apart from the month of March (0% increase), we have had substantial increases compared to the previous year. For example, in the month of April there was an increase of 41% (total collected \$829) and the month of May increased over 62% (total collected \$2,214).

We are getting closer to an agreement with the Suquamish Tribe for use of the breakwater. A refined proposal was sent to the attorney for the Tribe, and we are waiting to hear back from them. If all goes well, I'm hoping to receive approval from the Fish Committee within the next month.

As a reminder, I will start working on the 2024 budget within the next month. I will need a list of minor capital improvements and requested staffing for the upcoming year by mid-July. I would also suggest that the Board consider utilizing a workshop meeting to revisit the Comprehensive Scheme and verify that the Capital Improvements listed are still on track for the Commissioner's future vision of the Port.

WHEREAS, the Port Treasurer is designated to sign warrants, shall have an official bond for the faithful discharge of his or her duties, in the amount not less than fifty thousand dollars (\$50,000); and

WHEREAS, the Port Commission has adopted a procurement and public works policy that implements effective internal control for issuance of warrants and claims; and,

WHEREAS, the Board of Commissioners shall provide for it's review of the documentation supporting claims paid for its approval of all warrants issued in payment of claims and/or payroll at the next regularly scheduled public meeting; and,

WHEREAS, the Board of Commissioners shall require that if, upon review, it disapproves some claims and/or payroll, the Port Treasurer shall cause the disapproved claims to be recognized as receivables and to pursue collection diligently until the amounts disapproved are collected or until the Board of Commissioners is satisfied and approves the claims and/or payroll; and,

WHEREAS, the Board of Commissioners may stipulate the kinds or amounts of claims and/or payroll should not be paid before the Port Commission has reviewed the supporting documents:

# NOW, THEREFORE, THE PORT OF POULSBO HEREBY RESOLVES AS FOLLOWS:

The Port of Poulsbo does authorize the issuance of warrants before formal approval by the Board of Commissioners, provided that all conditions of RCW 42.24.180 have been met.
