#### Call to Order 7:00pm

#### **Commissioner Comments**

Commissioner Singer welcomed everyone and said Eugene has good updates to share.

Commissioner Rose looks forward to better weather. Eugene will be discussing safety. He encouraged everyone to go check on their boats and make sure things are repaired. Kitsap Call for All is next week. He reminded the PBA his spot for Commissioner chair will be open for the next election.

Commissioner Green said the Bainbridge Island Art Museum is part of a glass ball float treasure trek. It'll be six weeks long and you can find information on their website about where the glass balls are hidden.

#### **Public Comments**

Nico Jensen has been a liveaboard tenant for eight years. She's a small business over and restores boats on the side. She moors 2-4 big boats. She has a situation with one Port employees. He is known for targeting and vandalizing boaters. She has reported it and the employee admitted to knowing it was public gear. The employee has a criminal background, and she is fearful for her safety and property. This employee is verbally aggressive, yells profanities, and has felonies involving anger management and physical violence against women. Nico has discreetly communicated with the Port with little to no thoughtful response or consideration. The Port has ignored her emails and concerns since Mid-January. There have been 2-3 rightful grounds for termination, yet the person in question is still employed and protected by the Port. She wanted to share her comment publicly in case any harm comes to her, her partner, their boat, store, or a visiting boater or current tenant from this employee's anger management issues. The Port is fully aware of the employee's criminal history, tendencies, and lack of regard for the laws or rules. She said she is a liveaboard, this is her homelife, and this situation has caused significant stress and financial loss. The board has had no conversation about this. She takes it personally that the board is not taking her safety, and the others at the Port, seriously. She has had to get a lawyer involved just to use the public shower without said employee standing outside the bathroom holding the key.

Aaron Wenholz has been a tenant for over a decade and is aware of one pending lawsuit against the Port, and a similar potential lawsuit against the Port for similar reasons. He wondered if the Port has made any changes to the hiring process that has allowed felons into the liveaboards' world. He wants to know at what point will the blatant negligence stop.

## Commissioner Responses to public comments/discussions

Commissioner Rose reflected on the predominate issue of the last 100 days regarding the altercation. He said that Aaron and Nico's comments were succinctly put. He has reviewed all emails and unless mistaken, he has responded to all of them within an hour of receipt, except for one. One email he sent over six weeks ago outlined a sequential response to the best of knowledge. He concluded with both a personal and official apology as a Commissioner. He said it isn't like he hasn't had emotion in all this; things are not coming to fruition as we all would like. The Commission is dedicated and responsible to three issues: due process; honor and respect of the union areas; confidentiality. The board doesn't want to withhold, ignore, or abuse anybody. There are things the board doesn't know and things the board isn't allowed to know. There are things being done to correct somethings, but the board cannot impart that information yet and are not allowed to. He looks forward to some kind of reconciliation and they are trying to do the best they can. Background checks are part of what's happening. Protocols and procedures will be gong on. The board is working ahead on it.

Commissioner Singer appreciates Nico and Aaron's friendships. As for what Commissioner Rose said, confidentiality is what is at play. It's especially difficult and personally affects friends. The Port needs to work together, and with the City, to make sure things move forward in the right directions. Hiring policies and steps toward changing the hiring policies will be addressed in writing soon. Unfortunately, the issue still isn't over. The board wants to get over these things the right and legal way. Commissioner Singer wants to see the Port continue to grow.

Commissioner Green stated the Commissioners are public officials and not at liberty to speak freely. The process does take time. The Port had changed its policy over the last year so any recent employees hired should have, and would have, had background check.

# **Parking HDPA Port Interlocal Agreement**

Port Accountant Tripp had a meeting with the HDPA merchants downtown and believes there may be a way to achieve a mutual beneficial agreement to support merchants trying to access available parking. Since installation of Park Mobile, there has been a drastic increase in the amount of parking monies received. People are paying for parking, and this would also be mutually beneficial for the downtown merchants to enter an agreement with them to use 10-12 parking spaces on the Jensen Way lot to alleviate congestion downtown. She will be attending another meeting early next week and wanted some board input. She would need to run some numbers, but the Port would come out collecting money on a year-round basis on those 10-12 spots. The HDPA doesn't need the spaces during typical tenant hours. Port parking spots wouldn't be reduced. Tentative hours previously discussed were weekends 10am-6pm, and weekdays Thursday and/or Friday. She expressed no qualms over towing unpaid parking permits and can access such information directly from her phone.

Commissioner Singer said once the new downtown apartments open, there will likely be two cars per occupied apartments (there will be 46 apartments) and there are 40 designated spots. Parking will only get worse by the time summer arrives.

### **Future Changes to Marina Regulations**

Port Manager Madayag wants to include information regarding open flames, BBQs, and firepits. He has spoken with the Coast Guard and Poulsbo PD, and there are no regulations against them as long as the source is gas. Basically, it's not any different than a gas BBQ. He wrote something up to be added as a way to monitor any person who has a firepit. He read aloud his additions and described additions regarding electrical systems regarding marine grade cords.

Commissioner Singer suggested including size restrictions on firepits, and adding propane only, not gas.

Commissioner Rose recommended a weather-proof plug into the shore adapter.

Manager Madayag will write up the changes to the regulations.

#### **Kayak Rack Tariffs**

There are a total of 28 spots: four horizontal spots for bigger kayaks; 24 spots that are vertical. Port Accountant Tripp worked this out at \$25 per 10' kayak. Four horizontal spaces for \$30 for 12-14' kayaks. The Port already has a list of 18 people that want their boats there for a total of 20 spots.

### Request for future agenda items and public comments

There was a public comment from someone who recommended a specific extinguisher size, otherwise the device may be inadequate in the event of an emergency. It's something to consider because the Port could be liable for the damage. He wondered if the guy who rents boats in the marina has a parking permit.

Nico thanked the Commissioners for their replies. She said communication is the biggest issue they're having. There are multiple ways to reassure tenants when they're concerned about action being taken, even considering confidentiality and due process. She said people will always assume no action. She said if Commissioners want to speed up the process, they need to be gathering public statements. Not gathering statements tells her the Commission is not interested in pushing and learning the situation or getting details to push to the next level.

Councilman Musgrove said somehow the Easter events didn't make it on the community events calendar. The Chamber of Commerce is hosting Hopping Around Poulsbo for any age. People can go visit stores and get stamps. Once the stamp book is full, there is a raffle for some pretty awesome Easter baskets. The event goes through the 8<sup>th</sup>.

#### **Commissioner Comments**

Commissioner Green had no comments.

Commissioner Singer thanked everyone for their discussion. He's been thinking about things a lot. This Port has been here a long time. A lot of boats and events here. This summer he would be interested in a magnetic fishing contest for kids 15 and under. The Port would get the equipment and see what is "fished" out and host a BBQ.

Commissioner Rose said there were recent photo updates of the Valkyrie ship. The spars are cut, and the rutters are cut and shaped. The electrics are being worked out and the sails will be made. They're finding a way to unearth and launch it.
