Commissioner Comments

Commissioner Pfeil said it has been busy around the marina and a lot of miscellaneous things are being taken care of.

Commissioner Lawrence thanked everyone in attendance. He said Spring is coming and a lot of boats are coming in and filling the marina.

Poulsbo Boater's Association

There was no report.

Public Comments

John Coontz with the Olympic Outdoor Center hasn't heard anything since submitting his letter requesting the Port examine his lease. He asked the Port to meet with him. Commissioner Lawrence said the item will be added to the next agenda.

Nico Jensen said she heard at the last meeting the Port may be giving up the offices above the Marine Science Center. Boaters are saying it is a dealbreaker for the Tollycraft Club not to have the floating multipurpose room available to them. It would be a great alternative space that would also be a five-minute walk from the marina. She also gave kudos to whoever is running the social media content on Facebook.

Commissioner Lawrence said there was a guest moorage hiccup regarding wording. That is getting corrected. There will be a slight version readjustment and it'll be brought back for review at the first meeting in April.

Liberty Towing Contract

Port Accountant Tripp said the Jensen Way parking lot is bringing in more money. The paid parking plan will eventually continue with the City and the Port will need to monitor the lot more frequently for appropriate use and payment. A ticketing option is available with the contract. There is a memo from the Port Attorney regarding the legal authority the Port has. She will find the memo and send it to the board. The live-aboard parking situation cannot be altered unless there is a change to the number of live-aboard spots. There are also charging stations for electric vehicles.

Introduce Dave with the Poulsbo Police Department

Dave said there are problems in the bay that will be taken care of in the next few months. There will be some culture shock as things begin to be sorted out and he's aware of the real problem out there. He is here to help and to let him know if there's anything needed.

Commissioner Lawrence asked what are the anchorage rules for transient moorage. Dave said the state law is no boat can anchor in one spot for more than 30 days within a 365 period because it's public land. The boat will have to move within a five-mile range within that timeline. He stated 30 days is hard to enforce, and they won't be enforcing the 30-day rule because they'd have to contact every boat everyday for 30 days. Instead, they'll be abiding by the 60 or 90-day rule. At that point fines will start adding up. The Shoreline Master Program says only transient moorage is allowed to anchor and they're not legally allowed to anchor more than 60 days within a 365-day period. Those boats will be monitored for the 60 or 90-day rule. They want to clean up the bay and know there's a lot of work to do.

Commissioner Lawrence pointed out the running joke about towing derelict boats to Liberty Bay to get rid of them. Port Accountant Tripp stated the Port of Poulsbo needs to be notified before any vessel is brought by the City or any entity. Vessels have been towed to the Port multiple times in the past, which has negatively impacted the Port financially. The Port is no longer able to accept that kind of thing now. The Port will need to know ahead of time, and it will be a serious issue if any vessel is brought to the marina without explicit permission. Notification is critical and really impacts what kind of monies can be reimbursed.

Dave doesn't plan on bringing any vessels into the port and apologizes for what's been done in the past. He will keep everyone updated via meetings on progress and the status in the water.

Commissioner Lawrence wants everyone to work together. While the Port is part of the City, and the City brings a lot of tourism, the Port doesn't occupy all the parking spots.

Port Accountant Tripp wanted to clarify jurisdiction. She knows the Port has jurisdiction 200' outside of the breakwater and the City has jurisdiction halfway through Liberty Bay. She wanted to know if the City is planning to work with the Kitsap County Sheriff's Office when it comes to outside of City jurisdiction. Dave said that is the plan.

Public Comments & Requests for Future Agenda Items

Craig Muller, C-11, wanted clarification over written directions for permanent moorage parking. He's heard conflicting information. Port Accountant Tripp said the hours are 8am-4pm. The Port closes at 4:30pm and permanent moorage cannot park in those spaces.

Nico requested Employee Parking for the Port to be added to the next agenda. The Long Ship opens in the morning and four employees with four cars are required to move their cars for visiting tourists and shopping locals. Now that there are a lot of able-bodied people working at the Port, she thinks it would be fair to require them to park in the Jensen lot and walk to work.

Commissioner Pfeil wanted to address something received from the permanent moorage coordinator today regarding an exception for late fees. After brief discussion without revealing names or exact details, the board agreed not to waive any fees because the Port cannot gift public funds.

Commissioner Lawrence read aloud a statement about slips and waitlists. He thanked everyone for showing up. There have been some long meetings recently and there's still a lot of work ahead. The Port Manager job description will soon be available. He's hoping there are some good candidates in the works. As everybody knows, government doesn't operate quickly.
